



Treasurers Report for year 2008-2009

I have decided to include details of the various transactions in my reports. Please find attached summary of HNC's accounts 2008 – 2009 to date. I have provided balances and assets summaries for this financial year to date.

Cash accounts

At 27-02-09, of financial year the accounts are at follows: Current account £622.36 &
Reserve Account £900.69
Total cash value at 27/02/2009 is £1523.05

The HNC gets limited external funding, and hence most of the monies raised have been by the efforts of the HNC Executive committee, mainly from car boot sales. I would like to thank the committee for their efforts.

Expenditure is mainly on the clerks' honorarium, Events Insurance and advertising for HNC's events e.g. Car boot sales and the Historic Vehicle Rally.

You will notice that a sum of £1000 was transferred to the current account from our reserve account to pay outstanding invoices e.g. LCC for Christmas lights, and also the unpaid, clerks Honorarium.

However this money has been recouped from a succession the successful car boot sales, which raised £1705 over the year, despite one cancelation and one poorly attended due to adverse weather.

HNC has applied for a Local gateway grant with a view to raise much needed funding, to support the activities of HNC. The £1000 grant money has been specifically given to HNC for the purposes of upgrading the HNC web master's Hardware, and software packages.

I can report that we have had a successful offer of funding through the Gateway grant. This money will appear as two separate credits to HNC's current account on the 3rd Feb and 26th Feb respectively. £990.68 of this grant money has been spent on new IT equipment and related software to be used by HNC's webmaster.

Assets

A full list of the assets has been compiled and values assigned for the beginning of the financial year. Assets existing at the beginning of the year have been depreciated at 20%. Assets acquired during the year have been assigned their full value at the close of the year. With a depreciation of £243.82. Total value of assets as of 31/03/08 is £1,125.27 a decrease of £93.82 on the previous year.

At 31st March 2009 the projected value of the assets owned by HNC will be £900.22

Verification

There is no requirement to have the accounts formally audited. In view of the financial position of the HNC these accounts will not be formally audited. They will, however, be verified and checked by at least two people other than myself. This will be done before the next public meeting.
